What are KiddiVouchers?

KiddiVouchers are childcare vouchers which parents can receive from their employer instead of part of their salary. KiddiVouchers can be used to pay for many types of childcare, including nurseries, play schemes, holiday clubs, childminders and after-school care.

Parents don't have to pay any tax or national insurance on the vouchers, which saves families up to £2,392 a year.

What are the benefits for nurseries?

By helping parents to save money on childcare, vouchers make nurseries affordable for more parents. Using KiddiVouchers can provide parents with a real choice in deciding how much professional childcare to use.

When parents join a KiddiVouchers scheme, we provide them with a secure online account. Parents can keep vouchers in this account for as long as they like, which helps them save for the times when they need more childcare, such as school holidays.

Am I eligible to accept KiddiVouchers?

You are eligible to receive KiddiVouchers if you are registered with Ofsted (or the equivalent authority in Scotland, Wales or Northern Ireland), or if you are approved under the Childcare Approval Scheme. You can find out more about this by visiting our website.

How can I start accepting KiddiVouchers?

In order to receive payments from KiddiVouchers, you need to register. You can do this online at www.KiddiVouchers.com or by phoning us on 01386 793799. Once you have registered, we provide you with a secure online account. You can use this account to redeem paper vouchers or to view your statements.
